Dear Storage Participant:

Please note the following dates have been designated for the 2019/2020 vehicle storage season:
Saturday, October 26, 8:00 a.m. to 12:00 p.m. and Saturday, November 2, 8:00 a.m. to 12:00 p.m.

The entrance to the grounds will be, as in the past, from the Ironwood Road Gate #1. YOU WILL NEED TO REPORT TO THE FAIR OPERATIONS OFFICE BEFORE PARKING YOUR VEHICLE. The storage program is on a first come basis. Buildings are equipped with fire and theft protection, but are not heated. **NOTE: YOU MUST BRING YOUR OWN TOOLS AND COME PREPARED TO DISCONNECT AND/OR REMOVE YOUR BATTERY/BATTERIES.**

There will be one Saturday for removal, which will be **Saturday, March 28, 2020**, between the hours of 8:00 a.m. and Noon. If you were one of the last vehicles parked in a particular building, you must be here promptly on March 28 because until you remove your vehicle, no other vehicles will be able to move out. Please know that there will be an additional outside storage fee of \$10.00 per day, per vehicle, for any vehicle(s) not removed by March 28, 2020.

When you bring your vehicle for storage, you will be asked to provide the license plate number for the vehicle you are leaving for storage (for identification purposes). For your convenience, we have enclosed a release form you can complete prior to your arrival. This should help alleviate waiting in a lengthy line. Additional forms can also be found on our web site at www.4hfair.com. If you are not a member of 4-H Fair, Inc., you will be asked for a \$2.00 membership fee, which is good for a 5 year period.

Fees for the 2019/2020 season remain the same as last year and are set out on the enclosed page. These rates are determined by the TOTAL LENGTH, including tongue or other projections.

We will again offer an early storage program. Regardless of the type of vehicle, early storage will eliminate having to wait in line on either Saturday. The procedure and appointment times for the 2019/2020 season are as follows:

With an appointment that can be made any time after receipt of this letter, plus an additional \$25.00 per vehicle fee over and above the storage rate, you will be permitted to bring your car to the Fairgrounds between 9:00 a.m. and Noon, any Tuesday through Friday starting September 24.

With an appointment, Boats, Pontoons, Motorhomes, Campers, etc. will be permitted early storage for an additional \$25.00 per vehicle beginning Tuesday, October 22 through Friday, October 25, 2:00 p.m. to 7:30 p.m.

APPOINTMENTS WILL BE TAKEN BEGINNING THURSDAY, OCTOBER 10, 2019.

Note: During early storage, unless your vehicle is a motorhome, you will be dropping your vehicles outside the buildings where they will be stored and they will be put inside later that same day, and as time permits.
